





The aforementioned maximum rates include all items, including the cost of lines which, where appropriate, may be supplied by the tugs, except for the applicable VAT.

The rate to be applied to any vessel having its propulsion system out of service shall be subject to a surcharge of 50 %.

CONSIDERATIONS FOR THE APPLICATION

The rates indicated in the tables above shall be billable per berthing or unberthing manoeuvre irrespective of the number of tugs requested and/or actually used.

Towage operations in berthing, unberthing, escort, assistance and stay at port services as well as in special services shall be considered as independent services and therefore they shall be billable as per unit basis.

Manoeuvres for changing berthing between different quays and/or jetties shall be increased by 50 % of the relevant rate on the price of the service, provided that tow lines have remained firm on the tug.

No surcharge shall be added to the rates for towage services based on the time slot or schedule.

If the vessel does not have any pumping mechanisms or these mechanisms are not operational and the unloading process is executed by using any means supplied by the provider, the rental of such means shall amount to **€50/hour** or part thereof.

For those services provided to vessels located in Area II of the waters of the port or moored at the buoy fields of Area I of such waters the cost for maritime transport amounting to €489.60 shall be added.

The price of the service shall include:

- → Management of hazardous waste transport documentation (notification before transferring the wastes, control and follow-up documents, etc.).
- \rightarrow Waste sorting and separation.
- → Packaging and labelling, as well as packages and labels.
- \rightarrow Transfer to final managers.
- → Management of different wastes.
